² Of this amount, SilvermanAcampora LLP ("SA") has been paid \$814,555.92, in accordance with a monthly compensation Order of this Court, dated September 22, 2011, leaving a hold back of fees owed for the ninth interim period in the amount of \$203,639.73. SA's outstanding hold back is \$922,149.47. By this application, SA is seeking payment of \$250,000.00 of the outstanding hold back at this time.
