SilvermanAcampora LLP, counsel to the Trustee is seeking final compensation, inclusive of outstanding holdbacks in the amount of \$490,676.64, and expenses in the amount of \$4,368.82. Navigant Consulting, Inc., forensic accountants to the Trustee is seeking payment of its holdback in fees of \$21,440.40, and Paritz & Co., P.A., the Trustee's accountants are seeking payment of fees in the amount of \$43,950.00.
