<sup>1</sup> Of this amount, SilvermanAcampora LLP ("SA") has been paid \$225,888.80 in fees and 100% of the expenses in accordance with a monthly compensation Order of this Court, dated September 22, 2011, leaving a hold back of fees owed for the twelfth interim period in the amount of \$56,472.20. SA's outstanding hold back is now \$458,567.44. By this application, SA is seeking payment of \$50,000.00 of the outstanding hold back at this time.

<sup>2</sup> Although Navigant Consulting, Inc. is owed \$5,087.50 for the twelfth interim period, Applicant is seeking payment of 80%, or \$4,070.00 at this time, together with payment of a portion of its outstanding holdback in the amount of \$20,000.00, for a total interim payment of \$24,070.00. The new outstanding holdback will be \$21,711.65.
